- 1. The meeting was called to order by Vice Mayor Jerome Gnatek.
- 2. Answering roll call was Justin Buckley, Kenneth Vest, Loneta Hooper, and Vice Mayor Jerome Gnatek Mayor. Jim Wilhelms was absent.
- 3. Under Citizen's Comments, one citizen appeared before the Council to ask that her current bill of \$616.70 plus her next month's bill of \$393.00 be added together. The Council gave her four months to pay the total of the two bills.
- 4. Kenneth Vest made the motion to approve the minutes of the February 06, 2017 meeting and purchase orders for the Utility Fund, General Fund, Street & Alley, Fireman's Fund and Meter Deposits payable. - 8. Kenneth Vest made the motion to set up a budget committee to prepare a budget policy for the Town of South Coffeyville. The committee will consist of: The Mayor, the Vice Mayor, and Department heads. Justin Buckley seconded the motion. Yes votes were by Justin Buckley, Kenneth Vest, Loneta Hooper, and Vice Mayor Jerome Gnatek Mayor.
- 9. Justin Buckley made the motion to create a purchasing order ordinance on how we do purchasing for the Town. The ordinance will be presented to the Town Council by Police Chief Wade Lamb.
- 10. Kenneth Vest made the motion to vote 'yes' for the current Trustees for 2017 Trustees Election for OMAG Board of Trustees. Loneta Hooper seconded the motion Yes votes were by Justin Buckley, Kenneth Vest, Loneta Hooper, and Vice Mayor Jerome Gnatek Mayor.

Justin Buckley made the motion for the Fire Department to purchase a Briggs Motor, one set of bunker gear, a camera system, a Light Bar, a steel backpack blower, and a pair of telescoping lights, at an approximate cost of \$5,480.00.
