

**MINUTES OF THE

1. The meeting was called to order by Mayor Jerome Gnatek.

3. Answering roll call was Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
4. Citizen Comments--None.
5. Vice Mayor Kenneth Vest made the motion to approve the minutes from the June 28, 2019 regular meeting, July 01, 2019 regular meeting, and purchase orders for the Utility Fund, General Fund, Street & Alley, Fireman's Fund, and Meter Deposits Payable. It is then up to the council to decide to grant or deny the use of R.V. vehicles. The application will be available soon.
