1. The meeting was called to order by Mayor Jerome Gnatek.
2. The Pledge of Allegiance was led by Mayor Jerome Gnatek, and the prayer was led by Wade Lamb.
3. Answering roll call was Dorothy Perkins, Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
4. Citizen Comments--None.
5. Justin Buckley made the motion to approve the minutes from the September 3, 2019 regular meeting, and purchase orders for the Utility Fund, General Fund, Street & Alley, Fireman's Fund, and Meter Deposits Payable. David Rexwinkle seconded the motion. Yes votes were made by Dorothy Perkins, Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
6. Vice Mayor Kenneth Vest made the motion to approve a building permit at 310 Shawnee to move in a new trailer. Justin Buckley seconded the motion. Yes votes were made by Dorothy Perkins, Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
7. Vice Mayor Kenneth Vest made the motion to approve the building permit at 314 Walnut to for a storage building. Justin Buckley seconded the motion. Yes votes were made by Dorothy Perkins, Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
8. David Rexwinkle tabled the vote on the need for a permitting process for fireworks displays (1.3 g) within the city limits. More information was requested by the council. 10. No action--Discuss and vote to pay for the new chlorine and so2 pump for the sewer plant from the Utility Fund.



11. Dorothy Perkins made the motion to hire an employee for the office in City Hall. The city will advertise for a part time position (30 hours/week) with the intent of setting up interviews and hire at a later date. Justin Buckley seconded the motion. Yes votes were made by Dorothy Perkins, Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.

12. David Rexwinkle made the motion to table the vote to amend Ordinance 2018-10 regarding Medical Marijuana Establishments. The council requested the town attorney speak on this item next meeting. Vice Mayor Kenneth Vest seconded the motion. Yes votes were made by Dorothy Perkins, Justin Buckley, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
