1. The meeting was called to order by Mayor Jerome Gnatek.
2. The Pledge of Allegiance was led by Mayor Jerome Gnatek, and the prayer was led by Wade Lamb.
3. Answering roll call was Dorothy Perkins, Vice Mayor Kenneth Vest, David Rexwinkle, and Mayor Jerome Gnatek.
4. Citizen Comments—Darrell Thompson wanted to thank all who were involved with the Fireworks Show Sunday evening. He loved the fireworks.
5. Vice Mayor Kenneth Vest made the motion to approve the minutes from the June 21 and June 30, 2021 regular meetings, and purchase orders for the Utility Fund, General Fund, Street & Alley, Fireman's Fund, and Meter Deposits Payable.
