

**Minutes of the

1. The meeting was called to order by Mayor Jerome Gnatek.
2. The Pledge of Allegiance was led by Mayor Jerome Gnatek, and the prayer was led by Wade Lamb.
3. Answering roll call was Dorothy Perkins, Shelldon Rivers, Vice Mayor David Rexwinkle, and Mayor Jerome Gnatek. Tim Keeton was absent.
4. Citizen Comments--None.
5. Dorothy Perkins made the motion to approve the minutes from the March 7, 2022 regular meeting and purchase orders for the Utility Fund, General Fund, Street & Alley, Fireman's Fund, and Meter Deposits Payable. 6. There were no consideration of items to be removed from the Consent Agenda.

Report from Wade Lamb, Chief of Police -Reported he wanted to clarify the Street Legal UTVs have to be tagged with the state of Oklahoma to be driven on streets/roads, excluding highways. Also the new police vehicle will go to Emergency Vehicle Resources, LLC to be outfitted this week.

Report from Jim Wilson, Fire Chief --Thanked the Maintenance department for working on the grass truck last week.

Report from Steven Soule, Superintendent for Maintenance Department-Reported one of the maintenance workers was in class for Class D WasteWater and Water Class.

Report from Jenifer Hanigan, Deputy Clerk --No report.

Report from Mitch Lakey, Emergency Manager --Reported he had been contacted by CDL Electric about the siren that was ordered, and it should be here by Mid April. They would schedule installation then. The pulled pork fundraiser will be April 30th at the Fire Department.
